#### 5. Superintendent Report - Dr. Rui Dionisio, Superintendent of Schools -

Please join me in congratulating Mrs. Alina Dugan on her upcoming retirement. Mrs. Dugan plans to retire at the close of the 2020 calendar year. She will be greatly missed, especially by Dr. Lanzo! Mrs. Dugan has worked in the Verona Public Schools for the past 29 years and we are extremely grateful for her loyalty, commitment, and professionalism. Congratulations Mrs. Dugan.

The school reopening committees met last week for the first time and it was reported to me that those meetings were constructive and productive. I would like to thank our staff, parents, and administration for their participation. VHS and HBW committees met again today. The elementary committee will not meet this week with the Thanksgiving holiday. We are happy to have reconvened these committees and we are looking forward to the progress from these meetings.

The current state of COVID continues to evolve and is impacting our school district. I highlighted several important points yesterday evening in a letter to the community that is affecting our students and staff in all of our district schools. Yesterday, Monday, November 23, 2020, the Verona Public Schools confirmed three (3) new and unlinked individuals in our schools who tested positive for Coronavirus Disease 2019 (COVID-19). At that time, there existed one (1) new confirmed individual at Verona High School and one (1) new confirmed individual at H.B. Whitehorne Middle School. A third confirmed individual impacts both Brookdale Avenue Elementary School and F.N. Brown Elementary School. These cases are in addition to the reported case at V.H.S. on November 18th and H.B.W on November 22nd. The school district is working closely with public health officials and following CDC, state, and local health department guidance in order to ensure the health and safety of our community. The Montclair Health Department has notified any individual who is identified as being a close contact (6 ft or less for a cumulative 15 minutes or more within a 24 hour period) with the positive individual to self quarantine and monitor symptoms as a precaution as per the health department guidance. The New Jersey Department of Health (NJDOH) recommends that school districts should consider closing school to in-person learning for 14 days if 2 or more cases that are identified within 14 days occur across multiple classrooms, are not linked to exposures outside the school setting, and a clear connection between cases cannot be easily identified (outbreak involving multiple cohorts). As a result of the current circumstances impacting Verona, in accordance with NJDOH guidelines, and in consultation with the Montclair Department of Health and our district physician, Verona High School and H.B. Whitehorne Middle School will transition to fully remote instruction for the next 14 days. Remote learning at V.H.S. and H.B.W. began today, November 24, 2020 and will continue through Monday, December 7, 2020. Hybrid, in-person instruction will resume at V.H.S. and H.B.W. on Tuesday, December 8, 2020 barring no further transmission risk. Building principals have communicated with staff and parents regarding school schedules and further details. Additionally, the New Jersey Department of Health (NJDOH) released the latest COVID-19 Activity Level Report (Thursday, November 19), which includes data for the week ending November 14, 2020. The report explains that the COVID-19 activity level for the

Northeast region, in which Verona is included, is HIGH overall, and the COVID-19 case rate is identified as VERY HIGH. The last times our region was at Activity Level High (3) was March 21 and May 2-16. We anticipate people will travel and/or gather as a family this Thanksgiving and that our COVID number may grow. When discussing this possibility, in consultation with the Montclair Department of Health and our district physician, it has been determined that all district schools, including our elementary schools, will operate in full remote learning from November 30th - December 4th. The purpose of this remote learning period will allow our district to continue to monitor and evaluate the evolving number of confirmed cases and the impact on our students and staff. All of our elementary schools will operate on the remote learning schedule and return to hybrid, in-person instruction on Monday, December 7, 2020. Green phase: Low risk - Evaluate alternatives to in-person learning to ensure continuity of work or educational services; Permit limited activities involving interaction with multiple cohorts, ensuring adherence to precautions. Yellow phase: Moderate risk - Consider a mixture of remote and/or hybrid learning approaches, and/or fully remote learning; Minimize activities that involve interaction with multiple cohorts. Orange phase: High risk - Consider implementing fully remote learning; Restrict activities that involve interaction with multiple cohorts. Red phase: Very high risk - Must implement full remote learning. As we approach January, we will continue to monitor the evolving nature of COVID, exploring the possibility of taking added precautions. Our goal is to limit any transmission of COVID after the December break and we hope to provide an update to parents and staff next week to have a final decision so there is enough time for everyone to plan accordingly. We recognize this news is disappointing and the circumstances are not ideal, we will continue our efforts to return to in-person instructions as soon as it is safe for students and staff. We encourage parents, students, and staff to continue following the Centers for Disease Control & Prevention promoted safeguards in our communications, such as:

- Staying home when you are sick
- Washing hands often with soap and water for at least 20 seconds
- Covering coughs and sneezes and properly disposing of tissues
- Limiting close contact with people who are sick and not sharing food, drinks, and utensils
- Practicing social distancing (staying at least 6 feet apart)
- Wearing a face covering while in school
- Continuing to monitor your health for symptoms
- Following these measures and others will reduce the risk of transmission of COVID-19

Lastly, I want to take a moment to talk to you. As we approach Thanksgiving Day, a day that is grounded in respect for each other, camaraderie, and appreciation. I want to offer insight into our collective journey through this pandemic.

The climate and circumstances we find ourselves in today is more complex than ever. These last 9 months have challenged our fortitude and resolve. At times, it may feel as if there will be no end to this pandemic. But, we should remind ourselves

that we will get through these difficult times. When we ultimately come out on the other side, what will remain and be remembered is how we treated each other. Our present circumstances require focus and situational awareness. These are not times for distractions or divisiveness. In the best interests of safety and well-being of our students, staff, and the goals of our community, we must remain positive and focused.

Many of you are hurting. We have children sitting at home, filled with uncertainty because something they don't understand is keeping them from playing with friends, filling our halls with laughter, and just being carefree kids. We have parents who want their children in the school more often and others who want the school buildings closed so we can keep people safe. We have teachers who are concerned about getting themselves and their families sick and wondering how they can help their own children who are learning remotely in their home school districts. We have students who simply want to shoot a basketball, compete in a wrestling match, or perform on a stage. Let me be clear: We understand and truly care about our students, families, and staff. We recognize that words alone do not offer immediate solutions, but our school district will continuously analyze the data, consider the impact of our decisions, fight through obstacles, and use our combined strength to pull every single child through these challenging times.

If you flip open any of our history books, you will quickly find events that threatened earlier generations and posed major detours for the dreams of countless people. Our detour has altered some of our dreams and expectations, and we are all struggling to bear the weight of the massive challenges we are forced to confront. Let us not allow ourselves to be distracted or divided. Like our predecessors, although we are all not fully in agreement with the path we are taking, let's extend our arms, grab hold of everyone, and together get through to better times. Because, no matter how complicated life may get, our students are watching how we respond to adversity, and will use it as a blueprint for how they will respond to the challenges faced by their generation. What we want our students to learn from us during these times is how to respond to challenges using integrity, humility, and kindness. So, let's stay positive and productive. Let's work together.

We need everyone to get through this. We know there will be questions, disagreements, and doubt, but, if we work together and treat each other with respect, the Verona of tomorrow will emerge stronger than ever. There remains much to be thankful for this holiday season. I wish you and your loved ones a Happy Thanksgiving.
