# VERONA BOARD OF EDUCATION AWARDING OF PROJECT FOR TENNIS COURT, SYNTHETIC TURF FIELD AND SITE IMPROVEMENTS TO THE LANDTEK GROUP, INC.

WHEREAS, in accordance with a published bid solicitation for work associated with Tennis Court, Synthetic Turf Field and Site Improvements, in the Township of Verona, Essex County, New Jersey, Bid No. \_\_\_5\_\_ (hereinafter "the Work"), the Verona Board of Education received sealed bids on April 21, 2016; and

WHEREAS, in response to its bid solicitation for the Work, the Board received responses from five contractors; and

WHEREAS, after receipt of bids, the Board of Education caused an analysis of the bid responses to be undertaken by the Business Administrator, consultant staff as well as the Board Attorney; and

WHEREAS, as a result of that review, the Board makes the following findings of fact:

- 1. The Landtek Group, Inc. was the lowest prospective bidder with a base bid of \$5,899,815.
- 2. Upon review of the Landtek Group's bid submission, the Board finds the bid contains two waivable defects, neither of which confer a competitive advantage on the Landtek Group or a disadvantage to any other bidder.
- 3. Accordingly, the Board determines that the bid submitted by the Landtek Group is the lowest responsive and responsible bid.

WHEREAS, as a result of these findings, the contract for Tennis Court, Synthetic Turf Field and Site Improvements is awarded to The Landtek Group, Inc., in the amount of \$5,899,815.

NOW, THEREFORE, BE IT RESOLVED that the District's professional staff take any and all action necessary to effectuate the purposes of the Board's resolution in this matter.
