





### Drop-Off & Pick-Up Safety is Our Priority!

- No child should arrive to school before 8:15AM. This is the time at which staff is available to supervise students.
- All K-4 students should enter the building by way of Lanning Road, not Elk Rd. The Elk Road entrance is for pre-school children only.
- When possible, walk to school. This will reduce the number of vehicles in front of our school each morning. If you can't walk please consider carpooling.
- When dropping off students in the morning, please proceed as far forward as possible in your vehicle. This enables more vehicles to fall into line. Children will enter the building at the canopy entrance. Teachers will be in the hallway at 8:15AM to direct children to their classrooms.
- No parking, for any length of time, in spots designated no parking in front of our school.
- Please have students prepared at home so they may exit cars (curbside) in a timely fashion. Up to 125 vehicles drop off children within a ten minute span. We need to make space for these vehicles.
- Having students walk in between cars during pick up or drop off in the middle of Lanning Road is an unacceptable and dangerous practice.
- If you would like to "see" your child walk in the building, you must park legally and walk your child to the nearest entrance. No parking, for any length of time, in the drop off zone.
- All crossing of Lanning Road should only occur at the corner of Elmwood Rd or Otsego Rd.
- No vehicles should be entering or leaving the school parking lot on Lanning Road at pick-up or drop-off times.
- Children are not permitted to play in and around the side parking lot after dismissal.

## H.I.B.

- As per the Anti-Bullying Bill of Rights Act (ABR) (P.L.2010, c.122), Verona Public Schools has posted its Anti-Bullying Bill of Rights Act grades to the school district's HIB webpage, and to each individual school's webpages. Please feel free to contact Ms. Victoria Ramirez, District Anti-Bullying Coordinator if you have any questions.

## H.I.B.

The criteria for determining whether behavior or an incident is considered HIB is broken down into 4 prongs. Each of the following 4 prongs must be met for an investigated act to be considered HIB. The prongs are:

- 1. Any gesture, written, verbal or physical act, or electronic communication, whether a single incident or a series of incidents.
- 2. That is reasonably perceived as being motivated either by an actual or perceived characteristic, such as race, color, religion, ancestry, national origin, gender, sexual orientation, gender identity, and expression, or a mental, physical, or sensory disability, or by any other distinguishing characteristic.
- 3. That takes place on school property, at any school-sponsored function, on a school bus, or off school grounds that substantially disrupts or interferes with the orderly operation of the school or the rights of other students.
- 4. And that:
  - 1. Has the effect of insulting or demeaning any student or group of students; or
  - 2. Creates a hostile environment at school for the student; or
  - 3. Infringes on the rights of the student at the school.
  - 4. A reasonable person should know that will have the effect of physically or emotionally harming a student or damaging the student's property, or placing the student in reasonable fear of physical or emotional harm to his/her person or property; or

## H.I.B.

If an act does not meet each of the 4 prongs, it is most likely a code of conduct concern and will be dealt with in a serious manner by school staff/administration. If there is cause to believe that the act may meet the 4 prongs, it will be investigated and addressed in a different manner.

Parents may submit an HIB complaint form by visiting https://www.veronaschools.org/Page/8336. All suspected acts of HIB will first be reviewed through our pre-screening process prior to being referred for investigation to our HIB Specialist.

Affirmed HIBs may result in the student being recommended for educational and counseling services. Additionally, depending on the circumstances, school consequences as a result of violating the school's code of conduct may be applied.
