GENERAL INFORMATION

The YMCA of Montclair School Age Child Care Program is designed to provide care for children while parents are working. This program focuses on building self confidence and character. We emphasize the Y's four core values in character development — **caring, honesty, respect, and responsibility** - in every activity and interaction.

When children enter one of our state licensed Y SACC Programs, a world of growth opens up to them in a safe, fun and enriching environment. In addition to supplementing what they learned in school, they have the opportunity to participate in a variety of structured activities, get assistance with their homework from trained YMCA staff, have a chance to socialize with their peers and form new relationships. We also see an importance of giving them some time to participate in staff supervised free play, which is vital for their development, growth and self confidence.

Our goals are:

- To provide a warm, caring, and safe environment under the guidance of an experienced staff.
- To provide each child the opportunity to develop their self confidence and social skills.
- To provide developmentally appropriate activities that stimulate creativity and encourage learning through fun and discovery.

MEMBERSHIP

The School Age Care Program requires participants to have a current Y membership. The membership entitles a child, for additional fees, to participate in various programs. With a youth membership, a child may participate in open youth gym and swim times at no additional cost.

PROGRAM ACTIVITIES

The YMCA of Montclair School Age Child Care Program follows the standards of the National YMCA School Age Care Curriculum.

PARENT HANDBOOK

A parent handbook, program policies, and payment schedules can be downloaded at montclairymca.org. Enrollment and medical forms will be distributed at the time of registration or can be downloaded from our website. These forms must be completed and returned to the YMCA of Montclair, 25 Park Street, before a child can start the program.

PAYMENT POLICY

The School Age Child Care tuition fees are based on the number of school days, broken down to ten equal monthly installments for your convenience. The fee is not based on the number of calendar days per month, and no prorating of fees is allowed. The only exception is if beginning the month of October you enroll after the 15th of the month.

It is our policy that monthly tuition is paid in full. We do not prorate for absences or by the hour. If needed, children can be withdrawn for one or more months at a time. If a child is withdrawn, and that program has a waiting list, the child WILL lose his/her spot. We do not hold spaces under any circumstances.

ANNUAL CAMPAIGN

One in six students in the YMCA of Montclair School Age Child Care Program receives financial assistance through the Y scholarship program (\$17,800 per month). Your donation of any amount will have a direct and significant impact on a child in need. 100% of every donation received goes straight to the program, allowing the Y to serve as many families as possible.



EARLY REGISTRATION IS RECOMMENDED SPACE IS LIMITED

For all children who need to start the program on the first day of school — registration must be completed on or before Thursday, August 24.

**LATE REGISTRATIONS:
AUGUST 25 - SEPTEMBER 6**

Children registered between August 25 and September 6 will not be permitted to start the program until Monday, September 11.

Time is needed to ensure proper staff/child ratios. Beginning September 7, a waiting period of two business days is required before starting the program.

BLOOMFIELD

Children will participate in the School Age Child Care Program at the school s/he attends during the day. This program is offered in all of the district's elementary schools: Berkeley, Brookdale, Carteret, Demarest, Early Childhood Center at Forest Glen, Fairview, Franklin, Oakview, and Watsessing.*

BEFORE SCHOOL PROGRAM

Hours of operation are 7:30am to school opening. This program will not operate on days that schools have a delayed opening due to inclement weather or other reasons. Fees are per child.

Program Fees: \$165/month

Children can come any number of days in a month for one price per month.

AFTER SCHOOL PROGRAM

Program begins at school dismissal and children are to be picked up by 6:30pm On half days the program will begin at dismissal time (12:30pm). Fees are per child.

CEDAR GROVE

Program begins at school dismissal and children are to be picked up by 6:30pm. On half days the program will begin at dismissal time (12:30pm). Fees are per child.

VERONA

Children will participate in the School Age Child Care Program at the school he or she attends during the day. This program is offered in all of the district's schools: Brookdale Avenue, Forest Avenue, F. N. Brown, Laning Avenue, and H.B. Whitehorne.*

BEFORE SCHOOL PROGRAM

This program is offered in all of the district's elementary schools. Hours of operation are 7:30am to school opening. This program will not operate on days that schools have a delayed opening due to inclement weather or other reasons. Fees are per child.

Program Fees: \$160/month

Children can come any number of days in a month for one price per month.

EXTENDED KINDERGARTEN PROGRAM

Children will participate in the Extended Kindergarten Program at the school he or she attends during the day. This program is offered in all of the district's elementary schools. Program begins at school dismissal time (12:30pm) and children are to be picked up by 2:45pm.

Each day will include a balance of recreational and educational activities.

MONTCLAIR

Children will participate in the School Age Child Care Program at the school he or she attends during the day. This program is offered in all of the district's schools: Bradford, Edgemont, Glenfield, Hillside, Buzz Aldrin, Nishuane, Northeast, Renaissance, The Charles H. Bullock School, and Watchung.

BEFORE SCHOOL PROGRAM

This program is offered in all of the district's elementary schools. Hours of operation are 7:30am to school opening. When Montclair schools call a delayed opening due to inclement weather, the Before School Program will have a two hour delay and will begin at 9:30am. Fees are per child.

Program Fees: \$160/month

Children can come any number of days in a month for one price per month.

AFTER SCHOOL PROGRAM

Program begins at school dismissal and children are to be picked up by 6:30pm. On early dismissal days the program will begin at dismissal time. (Times vary according to schools.)

YMCA OF MONTCLAIR SCHOOL AGE CHILD CARE PROGRAM

E-PAY INFORMATION

We are happy to offer the option of paying tuition for the School Age Child Care Program through a monthly E-Pay plan. By utilizing this system, payments will be automatically deducted from your checking account or credit card on a monthly basis.

HOW DOES THE SYSTEM WORK?

1. You must leave a down payment equal to one month's tuition by the 1st of the month, and authorize the YMCA to charge your account directly for monthly payments.
2. On the 10th of the month, the YMCA will charge your account for the current month's tuition.
3. Your account will be charged each month until June 10.

WHAT WILL WE NEED FROM YOU?

To draft from a Checking Account:

1. "Pre-Authorized Monthly E-Pay Agreement Form" (School Age Child Care Program)
2. A blank, voided check from your account.
3. An initial down payment equal to one month's tuition.

To draft from a Credit Card:

1. "Pre-Authorized Monthly E-Pay Agreement Form" (School Age Child Care Program)
2. Credit Card number and expiration date from Visa, Master Card, Discover or American Express.
3. An initial down payment equal to one month's tuition.

GENERAL INFORMATION:

1. If a payment is not honored from either your bank or credit card for any reason, the Montclair YMCA imposes a \$20 Service Charge, in addition to any fees that your bank may charge. The E-Pay will be stopped for future payments and any outstanding child care balances must be cleared up before we can set up the account for automatic payments again.
2. If fees are continually unavailable from your account and payment falls behind, participants will not be allowed to continue in the program.
3. If we do not receive schedule changes by the 20th of the month, you will incur your originally scheduled tuition charge for the following month.
4. If your child withdraws from the program at any time during the school year, we must be notified by the 20th of the month or next month's tuition will be charged. Payments must be up-to-date at the time of withdrawal.

To take full advantage of this payment plan, we must receive your child's registration form, one month's payment (for September) and authorization by September 1st. We will begin charging your account on October 10th for October's Tuition.

You may take advantage of this payment plan at any time during the year provided we have the one month's tuition up front and your E-Pay information by the 1st of the month. Automatic deductions will then begin on the 10th of the following month.

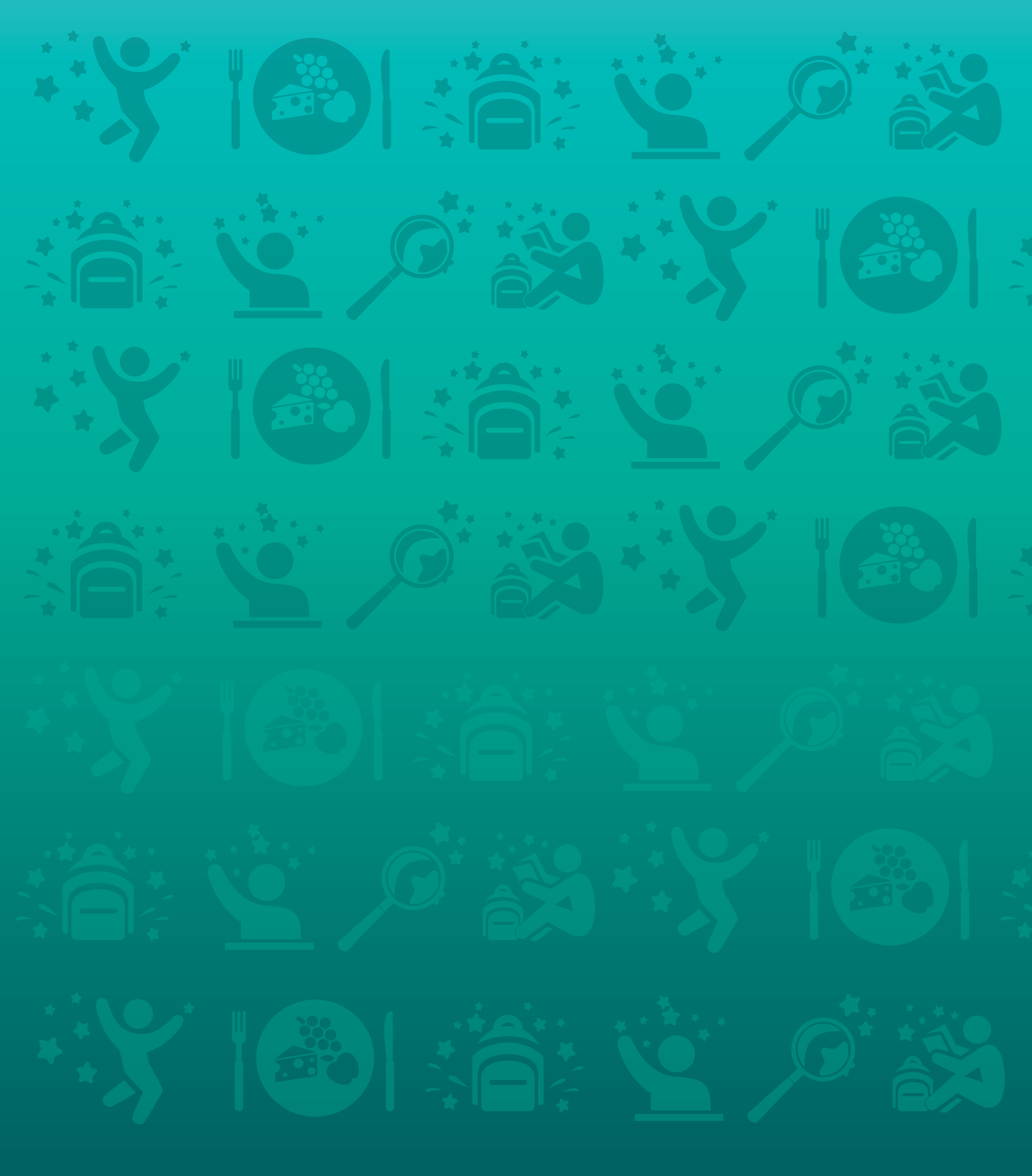
