Athletics

- Football scoreboard still not working.
- Former VHS soccer coach, George Stiefbold was honored. He won 11 conference championships and 7state championships over 4 decades. Also honored were 30 of his players from those championship teams from 1950's, 60's, 70's and 80's.
- HBW track needs resurfacing and field needs to be addressed.
- NCAA Parental Program held on October 11 to prepare students for those who want to participate in college athletics was a success.
- Tennis courts need to be resurfaced.
- My Locker Apparel is generating revenue for the athletic program when buying athletic sports wear
- Soccer parents are in the process of organizing a Boosters Club.
- The soccer parents want to bring the boys and girls teams to compete in Italy this summer.
- Our hockey team is playing a Canadian team on December 11.
- Mr. Farishian invited the 1950 Football team to attend a VHS football game.
- Mr. Jason Calo, our district athletic trainer, gave a seminar to the Verona Rescue squad on dealing with sports injuries.
